- 1. To discuss about Followup Action Taken on The directions of GB on the Report of ISAS HPC and decide further action in the matter.
- 2. Consider to ratify the decision of EC, for approval of the extension of term of the current EC up to 31.3.2023.
- 3. To amend the ISAS Constitution by adding another class of Membership titled Life Fellow and accordingly amend the following clauses of constitution of ISAS as follows:
- R-1-2: There shall be six classes of members of the Society as follows:
- a) Honorary Fellow shall be entitled for life to the rights and privileges of the members of the Society and in addition shall be exempted from the payment of subscription.
- b). Life Fellow, shall be entitled for life to the rights and privileges of the members of the Society and in addition shall make the payment of subscription prescribed for Life Member.
- c) Life Member shall be entitled for life to the rights and privileges of the members of the Society.
- d) Ordinary members shall be entitled to rights and privileges as prescribed from time to time.
- e) Associate Member shall be entitled to the rights and privileges of the members of Society, except the right to hold an elective office.
- f) Corporate Member who shall have the right to nominate two of his employees as representatives to enjoy the rights and privileges of the members of the Society, except the right to vote and the right to hold an elective office.
- R-1-3: The qualifications for the various classes of Membership shall be governed by the following principles:
- a). Honorary Fellow shall be a person of outstanding professional distinction in the field of Analytical Sciences and their applications and shall be enrolled only by invitation of the committee.

- b). Life Fellow shall be a graduate in science/engineering with a minimum of 10 years of professional experience or a postgraduate in science/ engineering with 5 years of professional experience, and having passed a prescribed Test & Interview conducted by ISAS or submitted a Fellowship Thesis, prepared under the guidance of an expert approved by ISAS, which is evaluated and found acceptable by the Committee of ISAS. Life Fellow shall pay the fees prescribed for a Life Member.
- c) Life Member shall be one who qualifies to be a member and who has paid the fees as per clause B-2-1 for this class of membership and approved by the committee.
- d) Member shall be a person enrolled by the committee, on passing a prescribed Test and Interview based on an application submitted by the person and/ or shall be a science/engineering graduate, who subscribes to the aims of the society.
- e) Associate Member shall be a person enrolled by the committee on application who has not attained the full qualification for the class of member, or who is not in service.
- f) Corporate Member shall be a registered commercial or industrial undertaking, a department of the Central or State Government, a local body, an institution or a recognized statutory body enrolled by the committee on application.
- 4. To discuss the ISAS Constitution containing all amends carried out from time to time (including the amends vide agenda 3 today) from inception and to accord validation and approval for the whole amended constitution of ISAS by the GB.
- 4. To appoint an Auditor for auditing accounts for the period of current EC and to fix the remuneration of Auditor.
- 5. Any other matter with the permission of the Chair.
